

REGULATIONS GOVERNING POST GRADUATE DIPLOMA PROGRAMME IN BHARATHANATYAM

(Framed as per Section 44(1)(C) of K.S.U. Act 2000)

1. TITLE AND COMMENCEMENT:

- i) These regulations shall be called “Regulations governing Post-Graduate Diploma Programme in Bharathanatyam”.
- ii) These regulations shall come into force from the date of assent of the Chancellor.

2. ELIGIBILITY FOR ADMISSION:

Candidates who have passed Bachelors Degree examination of Mangalore University or any other University considered as equivalent thereto are eligible for admission to this programme.

3. DURATION OF THE PROGRAMME:

The duration of the programme shall extend over two semesters (one academic year) each having a minimum of 16 weeks of instruction and two weeks Examination.

4. MEDIUM OF THE PROGRAMME:

The medium of instruction shall be English/Kannada.

5. HOURS OF INSTRUCTION PER WEEK:

There shall be 28-34 hours of instruction per week. These hours may be distributed for lectures, seminars, tutorials, project work, Manch Pradarshan and other modes of instruction.

6. ATTENDANCE:

Each paper (practical/theory) shall be treated as an independent unit for the purpose of attendance. A student shall attend a minimum of 75% of the total instruction hours in a paper (theory/practical) including tutorials and seminars in each semester. There shall be no provision for condonation of shortage of attendance and a student who fails to secure 75% attendance in a paper shall be required to repeat that semester.

7. MAXIMUM PERIOD FOR COMPELTION OF THE PROGRAMME:

The maximum period for completion of the programme shall be as prescribed in the regulation governing maximum period for completing various degree/ diploma programmes.

8. SUBJECT OF STUDY:

The subject of study shall comprise Origin and Development of Dance, Role of Carnatic music in Dance, Fundamental Technique, Basics in Carnatic Music, Raga Classification in South Indian Music, Advanced stage in music and Manch Pradarshan.

9. SCHEME OF EXAMINATION AND INSTRUCTION:

There shall be examination at the end of each semester ordinarily during November/December for the first semester and April/May for the second semester. The scheme of examination and instructions are as below:

10. INTERNAL ASSESSMENT:

10.1 Marks for internal assessment shall be awarded on the basis of performance in seminars, tests, assignments and Manch Pradarshan as determined by the Board of Studies from time to time. The internal assessment marks shall be notified on the college notice board for information of the candidates and thereafter it shall be communicated to the Registrar (Evaluation) at least 10 days before the commencement of the University examinations and the Registrar (Evaluation) shall have access to the records of such internal assessment.

- 10.2 Internal assessment marks shall be shown separately in the marks card. A candidate who has rejected the result or who, having failed to take the examination again or who has appeared for improvement shall retain the internal assessment marks already obtained.

11. REGISTERING FOR THE EXAMINATIONS:

A candidate shall register for all the papers in the subject of a semester when he/she appears for the examination of that semester for first time.

12. VALUATION OF ANSWERS/SCRIPTS/MANCH PRADARSHAN

Each theory paper shall be evaluated by eligible examiners. Manch Pradarshan shall be evaluated by internal examiner and the external examiner (other than the faculty member of the institution). Each practical examination shall be conducted and evaluated by one internal examiner and one external examiner or two external examiners if there are no internal examiners but not by two internal examiners

13. MINIMUM FOR A PASS:

- 13.1 No candidate shall be declared to have passed in a semester examination unless he/she obtains not less than 40% marks in the University Examination in each unit such as theory papers/ practicals and 40% marks in theory/practicals and internal assessment marks put together. In case of Manch Pradarshan, the candidate has to secure a minimum of 40% marks for pass.
- 13.2 There shall be no minimum in respect of internal assessment.
- 13.3. A Candidate who fails in any of the subject/ paper/ project work/ practical/ Manch pradarshan shall reappear in that unit/ and pass the examination subsequently.

14. CARRY OVER PROVISION:

The Candidate who fails in the first semester examinations may go to the second semester and take the examinations in that failed subject only at a subsequent semester examination.

15. CLASSIFICATION OF SUCCESSFUL CANDIDATES:

- i) The results of successful candidates at the end of II semester shall be classified on the basis of aggregate marks obtained in both the semesters.
- ii) The candidates who pass both the semester examinations in the first attempt are eligible for ranks provided they secure at least 60%.

- iii) The results of the candidates who have passed the II semester examination but not passed the first semester examinations shall be declared as NCL (not completed lower semester examinations). Such candidates shall be eligible for the degree only after completion of all the first semester examinations.

Percentage of marks for declaring class:

First Class with Distinction	:	70% and above
First Class	:	60% and above but less than 70%
High Second Class	:	55% and above but less than 60%
Second class	:	50% and above but less than 55%
Pass class	:	40% and above but less than 50%

16. REJECTION OF RESULTS

- 16.1 A candidate may be permitted to reject the result of the whole examination of any semester. Rejection of result paper-wise/subject-wise shall not be permitted. A candidate who has rejected the result shall appear for the regular examination following immediately.
- 16.2 The rejection shall be exercised only once in each semester and the rejection once exercised cannot be revoked.
- 16.3 Application for rejection along with the payment of the prescribed fee shall be submitted to the Registrar (Evaluation) through the college of study together with the original statement of marks within 30 days from the date of publication of the result.
- 16.4 A candidate who has rejected the result is eligible only for class and not for ranking.
