


- The meeting began at 03.00 pm. Initially, Prof. Monika Sadananda took up analysis of criterion I in detail. She said that **only one metric** can be taken up for appeal in this criteria. Also, she made some recommendations for the future:


1. Courses directly leading to employability/entrepreneurship/skill development have to be identified, and the following documentation to be prepared.

- a) Activities/Content with direct bearing MoUs.
- b) BoS proceedings with approval for these courses.

2. New courses to be added during each revision at least as Soft core courses.
 3. Prepare department-wise ATR on feedback.
- Prof. Boja Poojary, presented a detailed analysis of Criterion IV and said that appeal could be made on only one metric; and that it was connected to the extended profile.
 - Prof. Y. Narayana, presented the detailed analysis of the Criterion V. He also mentioned that frequent changes in the SOP had affected more metrics in this criteria. He said that appeal could be taken up for 4 metrics in this criteria.
 - Prof. Shivalingaiah suggested the following points -
 - When referring to SOP mention the date of the SOP.
 - Appeal for only for those metrics where we can get good score.
 - To compare the SOPs which were uploaded in December and February.
