

# **STATUTE GOVERNING THE PAYMENT OF RESIDENTIAL TELEPHONE CHARGES OF NON - STATUTORY OFFICERS OF THE UNIVERSITY.**

(Framed under section 40 (1) (p) of the K.S.U. Act 2000)

## **Preamble:**

Mangalore University campus, Mangalagangothri is located in about 20 km. from Mangalore city proper. There are at present 170 affiliated colleges and two constituent colleges of the University. The University campus itself has 25 postgraduate departments having 35 postgraduate programmes. In order to deal with the academic, research and developmental activities of the University, there are various administrative staff in addition to the statutory officers of the University. Since the University is not in a position to accommodate all the officers of the University on the campus, some of the officers are residing in various places around the campus and at Mangalore city. Often, in the interest of speedy communication and arrangements for the meetings etc. these officers have to contact others over their mobile or landline particularly during outside office hours and holidays. In view of this it has become necessary that these officers have to be either provided with residential/mobile phone facilities or the expenses incurred by them have to be paid by the University at a reasonable rate. Of the two alternatives the Syndicate is of the opinion that the latter arrangement will be better and cost effective. Hence it has been decided to fix a reasonable amount for payment of residential telephone charges of certain non statutory officers of the University. The Govt. Auditor has suggested that a Statute is necessary for this purpose.

Hence this Statute.

## **I. TITLE AND COMMENCEMENT:**

- i) This statute shall be called the “Statute Governing the payment of residential telephone charges of non - statutory officers of the University.”
- ii) This statute shall come into force from the date of assent of the Chancellor.

## II. APPLICATION:

The following non - Statutory Officers of the University are eligible for the payment of the amount specified against their designations.

1.	Principal University College, Mangalore	Maximum 1,000 calls per month and Rent
2.	Principal, Field Marshal K.M.Cariappa College, Madikeri	Maximum 1,000 calls per month and Rent
3.	Medical Officer	Rs.500.00 per month
4.	Special Officer Office of the Registrar (E.)	Rs.500.00 per month
5.	Deputy Registrars	Rs.500.00 per month
6.	Assistant Registrars	Rs.500.00 per month
7.	P.S. to Vice Chancellor	Rs.500.00 per month

## III. EXTENSION OF THE BENEFIT:

The University Syndicate shall be empowered to revise the charges from time to time and extend the benefit to any other non – Statutory Officers of the University.
